Dear Sheep Breeder,

Plans have been finalized for the 38th Annual New York Bred Ewe, Ewe Lamb & Angora Goat Show & Sale and you are invited to consign. Banner Sale Management Service is truly excited to once again have the opportunity to manage this prestigious sale.

Once again this year is the inclusion of rams as well as Angora goats to the sale. One new feature in this year's sale is the addition of crossbred wool breeds for improved fleece quality, and classes for crossbred wether-type dams. Details are included in this letter. We really encourage you to enter the sale with some of your best animals possible. More numbers entered will bring more buyers and the added attraction of used sheep equipment will help bring more breeders and potential buyers to the sale.

This letter contains the rules and conditions that the sale will be held under. Also included is a sheet listing the 2017 General Sales Information that applies to Banner Sale Management Sales in general. Please carefully read this information.

Show & Sale Date: October 19 & 20, 2018

Location: Dutchess County Fairgrounds, 6550 Spring Brook Ave, Rhinebeck, NY 12572

Schedule: Show – Friday, October 19 – 1:00 p.m. Sheep followed by Angora Goats
Sale – Saturday, October 20 – 10:00 a.m. Sheep followed by Angora Goats

Sheep Judge: Woody Joslin, Maplewood, OH

Goat Judge: Fred Speck, TX

Auctioneer: Tyler Lobdell, Illinois

Entry Deadline: Mailed entries must be postmarked by September 1. Online and faxed entries are due September 5 (*Please get your entries in on time!*) to be included in the sale catalog published in the September issue of The Banner.

Entry Fee: \$30.00 per head. All entry fees are due at the time entries are made and are nonrefundable.

Commission: 10% of the gross price.

Sponsorship: The sponsors of the sale, Dutchess County Sheep and Wool Growers Association, receive an additional 2 % of the sale gross on all sheep and goats sold in the sale.

Breed Fees: The American Corriedale Association, Inc. requires us to deduct 1% of the gross on Corriedales sold.

Breeds: The New York Bred Ewe, Ewe Lamb & Angora Goat Show & Sale is open to all breeds of sheep and to breeders from all parts of the country. We are expecting entries from the following breeds: Bluefaced Leicesters, Border Cheviots, Border Leicesters (White & Natural Colored), Columbias, Corriedales, Cotswolds, Hampshires, Horned Dorsets, Icelandics, Lincolns (White & Natural Colored), Merinos, Natural Coloreds, North Country Cheviots, Oxfords, Polled Dorsets, Polypays, Rambouillets, Romneys (White & Black), Shetlands, Shropshires, Southdowns, Suffolks, Tunis, Crossbred Wool Breeds, Crossbred Wether Dams.

Sheep Sale Classes:

Yearlings Ewes (9/1/16 – 8/31/17)

Bred Ewes up to four years of age (9/1/14 – 8/31/16)

Fall Ewe Lambs (born 9/1/17 – 12/31/17)

Spring Ewe Lambs (born 1/1/18 & after)

Rams: 1 entry per consignment. To sell a ram you must enter 2 ewes of the same breed. Only yearling rams or ram lambs may be sold.

Goat Sale Classes (Classes for both Registered & Unregistered Goats):

Yearling Does (1/1/17 – 8/31/17)

Kids (born 1/1/18 & after)

Mature Does up to 4 Years of Age (9/1/14 – 12/31/16)

**Be sure to designate Registered or Unregistered when entering

Used Equipment Consignment Auction: 20% Commission is charged.
Equipment will begin selling 30 minutes following the sheep and goat sale.

Equipment Check-in: Equipment check-in will be from 2-6 p.m. Friday evening in the sheep sale office.

Equipment Drop-off: All equipment may be put on display following check-in or beginning 8 a.m. Saturday morning in a designated area in the sale pavilion. All equipment must be in place by 9:30 a.m. Saturday.

Fleece Length: All animals should be properly presented for show. Southdowns follow American Southdown Breeders Association rules to be slick shorn.

Sheep Registration Papers: All animals in all registered classes **must** have a valid registration paper. All registration papers are to be turned in to Banner Sale Management at check-in. These registration papers will be transferred and forwarded to the buyers. Cost of transfers will be deducted from consignor settlements.

Goats: May be registered or unregistered.

Bred & Exposed Ewes: ALL EWES, YEARLINGS AND OLDER, MUST SELL AS EXPOSED OR BRED. Service sire information and breeding certificates must accompany ewe registration papers at check in.

Sheep Health Papers: You must have an individual currently valid health paper for every animal you sell issued within 30 days of the sale. A Federal Scrapie ID Tag must be in each animal's ear. This applies to all animals in all classes.

The following information must be legibly written or typed on all health papers:

- 1) Owner or consignor name & address
- 2) Species & purpose of movement
- 3) Private flock tag number **and**
- 4) Federal scrapie ID number (must be complete)
- 5) Age, sex, and breed of each animal
- 6) Signature and printed name, address and phone number of accredited veterinarian.

As a consignor, please take the responsibility to ensure that all of the above information is complete and legible. It is your responsibility to provide the sale manager clear and legible copies. You will need two copies for each animal in your consignment. (3 animals = 6 copies)

Goat Health Papers:

1) Health certificate, appropriate for your situation (either INTRAsate or INTERstate). Proof of Rabies vac. within 1 year of show date is strongly recommended but not required. Please make sure that your unique farm ID is clearly visible on the health forms and that it is used to identify EACH animal listed on the form.

2) Scrapie tags/ ID - MUST be in place for all animals attending this show.

3) This includes animals within NY State. Any questions please check with your vet.

The NY State USDA Tech does attend this show and will be checking animals for proper ID/scrapie compliance. The only exception to this requirement is - registered animals with registration papers accompanying each animal. The identifying numbers on the registration form MUST match the chosen farm identification, as well as the identifying marks or tags on the animal. A tattoo used for identification purposes MUST be readable or it will NOT be accepted. Original registration forms and NOT COPIES must be presented.

4) Federal Scrapie ID number (must be complete).

Goat Fleece Requirements – same as the goat show:

1) Goats should be shown in fleece with growth of 4-6 months.

2) Fleece clip should be appropriate to age of goat, ie. Kids should be presented in 1st or 2nd clip fleece, Yearlings in 3rd or 4th clip fleece, Adults 5th clip fleece or greater. Goats in clip not appropriate to age may be disqualified or placed lower in class depending on judge's decision. Any questions please contact us. Judges decisions are FINAL.

3) Good goat grooming for a show includes hoof trimming and the removal of stained hair/manure tags from the animals' rear end and pizzle areas. Goats MAY NOT be washed or the fleece treated with any conditioners or any agent to soften or otherwise alter the natural state of the fleece. Exhibitors using a "pour-on" agent for external parasite control should not apply the agent in the several weeks immediately prior to the show.

Sale Catalogs: A complete Sale Catalog will appear in the September Issue of THE BANNER SHEEP MAGAZINE as well as be posted on the web at www.bannersheepmagazine.com. A link will also be made to the New York Festival website. As in previous years, we also direct mail to a large list of potential buyers. If you know of anyone who would like to receive a catalog, please refer them to our website or provide us with their full name and address. The entry fee provides you a space to write about your entries and pedigrees, 50 words maximum. Any over that will be edited. With this information, we can do a much better job of selling your sheep and goats. "Information Sale Day" sells few sheep and goats!

Sale entries may be made using the method of your choice. You may mail or fax the enclosed forms to us. Online entries are available at www.bannersheepmagazine.com using PayPal. All entry fees are due at the time entries are made and are nonrefundable. Emailed entries of any form or format are not accepted. Telephone entries will not be accepted. Please use only one method to submit entries and do not send duplicate entries. Banner Sale Management takes no responsibility for entries not received and reserves the right to refuse any entries submitted.
